1.0 **OBJECTIVE:**

To lay down a procedure for Retesting of Packing materials.

2.0 SCOPE:

This SOP is applicable for Retesting of Packing materials in Quality control department.

3.0 **RESPONSIBILITY:**

Executive, Officer – Quality Control

Head - Quality Control

4.0 **PROCEDURE:**

4.1 Sampling of Retest Packing Materials:

- 4.1.1 Warehouse shall be intimated to Quality Control department for retest date.
- 4.1.2 Retesting of Packing material shall be initiated after receiving the intimation from warehouse.
- 4.1.3 Follow the retest period of materials as specified in annexure-I.
- 4.1.4 In case of phase to phase transfer of material, the initial retest date shall be considered.
- 4.1.5 QC officer shall enter the material details in Packing material retest inward record and shall assign new A. R. No. by putting a prefix P1, P2 and P3 for each batch/ lot to the original A. R. No. of Packing materials for retesting 1st time, 2nd time and 3rd time respectively as per annexure-II.
- 4.1.6 QC Officer shall prepare Under test labels as per received intimation slips for each package.
- 4.1.7 Perform the Sampling, Testing, and Release or Rejection of Packing material as per current SOP.

4.2 Frequency for Retesting of Packing Materials:

- 4.2.1 All Packing materials shall be retested as per Annexure-I.
- 4.2.2 For primary Packing material retest period is 364 days & for secondary and tertiary it would be 729 days (if material is used as either primary or secondary Packing material then retest period to be considered as 364 days) from the date of release unless otherwise mentioned in
