6.0 PROCEDURE:

- **6.1** The service for Pest and Rodent Control / Disinfection shall be arranged on Contractual Agreement with Professional Organization.
- 6.2 The service covers disinfection of all Pests, like Cockroaches, Rodents, White Ants, and Silver Fish etc.
- 6.3 The required documentation shall be maintained by the house keeping personnel. These documents shall be signed by a person, section In-Charge of that department after verification.
- 6.4 In case of any complaint after servicing, the contractor sends a responsible person from their office to attend the same and render additional service for effective control.
- 6.5 Pest & Rodent control contractor shall carry out pest control and rodent control as per the frequency mentioned as per the **Annexure-VII**, Titled "**Handling and Usage of Chemical Pest Control**". However if required they shall carry out extra treatment to eliminate / reduce the menace of the pest and rodent in the premises.
- **6.6** Pest & Rodent control contractor shall exclusively use ISI marked and approved by WHO for public health program, insecticides.

- 6.7 Pest & Rodent control contractor shall carry out all spray based chemicals diluted exclusively with water and in no circumstances kerosene will be used as diluting media; however kerosene can be used only outside the office buildings.
- 6.8 Pest & Rodent control contractor shall take all possible precautions and ensure no contamination of chemical spray into in-process materials, water and raw material kept open inside the premises.
- 6.9 Pest & Rodent control contractor shall not be provided with any manpower from our and therefore they have to carry out all activity related to above work.
- **6.10** Pest & Rodent control activity shall be performed by trained person of contractor.
- **6.11** Pest & Rodent control contractor shall be solely responsible for any kind of accident / loss / injury to them personnel during treatment operations in factory premises.
- **6.12** Pest & Rodent control contractor shall submit a safety policy of his organization in they letterhead and personnel has to abide by the said policy.
- 6.13 Pest & Rodent control contractor shall also abide by the safety Rules of, and shall follow all safety norms and work permit system prevailing at
- **6.14** Pest & Rodent control contractor shall submit a copy of they license from Central / State Government toward use of Insecticides for carrying out the aforesaid work.
- 6.15 All chemicals insecticides required for pest control shall remain in custody of contractor person, responsible for Pest & Rodent control activity.
- 6.16 Pest & Rodent control contractor shall mark on plant layout plan about the area where they will be spraying chemicals & fixing the Rodent Box.
- 6.17 The work will be supervised directly by them visiting the factory minimum twice a month or weekly or early, as per the requirement of the factory.
- **6.18** Pest & Rodent control contractor have to dispose of empty container of insecticide.
- **6.19** Verification of bills as per the work done at factory and as per the bill submitted by Pest & Rodent control contractor.
- **6.20** Record the Pest & Control Activity in "Pest Control/Rodent Control Record" as shown in Annexure-I to Annexure-VI.
