To lay down a procedure for Operation and Cleaning of Garment Washing Machine.

This SOP is applicable for Operation and Cleaning of Garment Washing Machine in Microbiology Lab of Quality Control Department.

#### **6.0 PROCEDURE:**

#### **6.1 OPERATION:**

- **6.1.1** Ensure cleanliness of Machine & Surroundings.
- **6.1.2** Open the valve of Soft water.
- **6.1.3** Switch "ON" the electric supply from main panel.
- **6.1.4** Press the power button to turn power on.
- **6.1.5** Add the detergent 0.2 % sodium Lauryl sulfate (SLS) through detergent charging port (Approx 8.0 liter water to be used for washing).
- **6.1.6** Open the lid and load the garment as per load pattern into the washing tub and close the lid.
- **6.1.7** Press the program button to select the program (Quick 30) and the start the cycle for 30 Minutes in Auto Mode.

- **6.1.8** Automatically washing cycle will run & then drying (Super Dry) the cloths cycle will run.
- **6.1.9** After completion of garments drying cycle, Washed garments shall be inspected physically for any damage of garments like garments retained the colour, no damage and holes, complete dryness and the easy movement of zips.
- **6.1.10** 'End' massage is displayed, then Switch "OFF" the Electrical supply of the Washing machine. Open the door & Collect the dried Garment from the machine.
- **6.1.11** Place all the washed & dried garments on SS table provided in Garment washing room.
- **6.1.12** Make set of garment—Boiler suit, Booties, Head Gear, Put into the lint free cloth bag for Sterilization.
- **6.1.13** Record the operation details in "Operation and Cleaning Record of Garment Washing Machine" as per Format shown in Annexure-I.

#### 6.1.14 Load Pattern:

| S.No. | LOAD PATTERN         | Qty.               |
|-------|----------------------|--------------------|
|       | Boiler Suit          | 05 Nos.            |
| 1.    | Head Gear            | 05 Nos.            |
|       | Bag                  | 05 Nos.            |
| 2.    | Booties              | 10 Nos. (05 Pairs) |
| 3.    | Lint Free Moping Pad | 05 Nos.            |

#### 6.2 CLEANING:

- **6.2.1** Switch "OFF" the Machine.
- **6.2.2** Clean inner & outer surface of washing machine with Lint Free Cloth.
- **6.2.3** Mop inner surface as well as external surface with 70% IPA.
- **6.2.4** Wash the surface with sufficient quantity of Purified Water.
- **6.2.5** Mop the inner and outer surface with Dry Lint Free Cloth.
- **6.2.6** Record the cleaning details in "Operation and Cleaning Record of Garment Washing Machine" as per Format shown in Annexure-I.
