1.0 OBJECTIVE:

To lay down a procedure for De-Labeling of Bottles.

This SOP is applicable for De-Labeling of Bottles in Production area.

6.0 PROCEDURE:

- 6.1 During labeling operation, Bottles are rejected due to improper pasting, Peeling off the label, smudging of coding details, partial overprinting matter defects etc.
- 6.2 Arrange label rejected bottles vertically in trays.
- 6.3 Do the wet mopping of bottles label by lint free cloth and wait for few minutes.
- 6.4 Ensure that during de-labeling process bottles do not dip completely into water inside the tray.
- 6.5 Ensure that any sharp edge utensil i.e. knife, blade shall not be used for de-labeling of bottles.
- 6.6 Ensure that bottles shall not be scratched during de-labeling.
- 6.7 Manually remove label from all the bottles and clean them properly.
- 6.8 Count all the de-labeled bottles and make entry in BPR.
- 6.9 After QA approvals re-label these bottles.
