4.0 PROCEDURE:

4.1 Numbering system of validation documents:

4.1.1 The numbering system followed for Validation of Microbial Limit Test Protocols shall be as follows:

PD/XXX/PMLT/YY/ZZ

PD : Stands for Pharmadevils

XXX : Stands for Department code

PMLT: Stands for Protocol for Microbial Limit Test.

YY : Stands for serial number

ZZ : Stands for the version number starting from 00.

Example: PD/QCM/PMLT/01/00

4.1.2 The numbering system followed for Validation of Microbial Limit Test Reports shall be as follows:

PD/XXX/RMLT/YY/ZZ

PD : Stands for Pharmadevils

XXX : Stands for Department code

XXX : Stands for Department code

RMIS: Stands for the miscellaneous report

YY : Stands for serial number

ZZ : Stands for the version number starting from 00.
